1. Legal Land locations

4. Fees and Charges

i. Each application will be subject to a \$400 + GST non-refundable application fee.

ii. Each Expansion acre awarded will be subject to a \$1,450 +GST per acre Capital Asset fee.

a. 10% of this total is due at application as a refundable deposit.

iii. If previously awarded Annual Acres, the Capital Asset fee paid, will be added to this application as a credit towards the Total Remaining amount.

5. Applicant Priority - If submitting more than 1 application, please enter your priority for consideration.

6. Approved acres will be awarded in 2024, Acres replacing acres that were irrigated in 2023 with an Annual agreement or Alternate Parcel may be available as permanent Irrigation Acres for the 2024 season and assessed as Irrigation Acres. New Parcels not previously irrigated may be issued as an Annual Agreement and assessed as an Annual agreement in 2024. The Capital Asset fee for the 2024 year is \$1,450.00 per acre and is due 60 days after finalization approval by the Board.
